### Message from the ICW-CIF President



My dear ICW sisters and friends, and distinguished guests,

What a great pleasure and honor it is for me to be with all of you here in the beautiful city of Avignon on this special occasion of the ICW's 36th General Assembly. Here we are again, in the land of rich culture and history to renew and reaffirm our ties and clarify our goals.

I hope you know how much I appreciate your presence today. I heartily welcome everyone here. I'd also like to express my

deep gratitude to our host, the National Council of Women of France (NCW France) and its president, Marie-Claude, for their supreme effort to make this event successful.

Over the past 2 years, the COVID-19 has aggravated gender inequalities and injustice. Millions of women around the world have been forced out of work, resulting in abysmal economic and social impact for women. Likewise, the number of women who have fallen victim to all forms of violence has skyrocketed. Along with these many, many instances of unfair and abusive treatment we witness a strong pushback on women's rights. This, we believe, demands strong and effective action.

As you no doubt know, ICW and NCW France have a long, solid tradition of very friendly and cooperative relations. I believe this can serve as an excellent example of the utility and effectiveness of networking. Clearly, working together to accomplish the common goals of gender equality and the empowerment of women is vastly superior to individual action.

It seems the voice of women is clearly heard in France. Since its founding in 1901, NCW France has demonstrated wonderful leadership for the advancement of women. They have made great progress in furthering gender equality and women's empowerment. I've been most impressed by how NCW France and the French government have been able to see eye to eye regarding important gender-related matters, and mutual understanding has led to meaningful legislation. This goes to show that when elements of resistance are identified and sound proposals made, one can expect progress.

Great effort has been made in France to place women in more important roles in government and business. According to recent statistics, around 50% of ministers in the current French Government are women, while women also hold 39.5% of parliamentary positions and 43.4% of higher business positions. The women leaders of France, past and present, are well known as true pioneers in the struggle for gender equality.

For now, only about half of the women globally participate in what might be called meaningful economic activities. On average, women receive only 64% of the wages paid to men. Although the percentage of women in higher business position and in political leadership slots has been on the increase, the current global average of women on board directors is a mere 24.4%. Furthermore, Globally, women are only 13.5% of the top government leaders, 26% of ministers, and 26.1% of parliamentarians. These figures amply demonstrate the level of discrimination against women today, and this is, in my opinion, neither to be ignored nor accepted.

The mechanism for improvement would be to find more women advancing into politics and economics at all levels. This could provide a critical platform from which the voice of women can be heard and ideas of equality vigorously promoted.

This afternoon, the women's forum will be focused on the best practices to achieve women's rights and empowerment on the measures of social protection for women and girls.

Ever since ICW was established as the first international women's NGO in 1888, we have made a concerted effort to proactively promote gender equality as a central tenet of international law. We have always been at the center of the women's movement, striving tirelessly to improve the lives of women throughout the world.

This year marks the 134th anniversary of ICW founding. As such, for more than a century, ICW has remained an active pioneer in voicing the concerns of women and promoting international women's rights. We should continue in all earnest to build on that tradition and redouble our efforts to make the world a safer and happier place, not only for us, but for all women of the world.

Quite candidly, I can't remember a time of greater challenge in our pursuit of gender equality. Global turmoil brought on by disease, war, extreme climate change, and possible widespread economic recession combines to create a situation that I have not observed in my seven years representing ICW. But what does this tell us? To me, it underscores the extreme importance of working as hard as we can, in unity, toward goals that we know are just.

I expect fruitful results from this Avignon General Assembly. I would appreciate your active participation in the programs we have planned. Through this event, I am confident that we will be strengthening our solidarity and sense of sisterhood by sharing our ideas and understandings. Together we will move forward despite any challenges we may face.

I would once again like to thank President Marie-Claude and her talented colleagues for their passion and leadership to ensure the grand success of this event.

I hope that all of you have a moving and enjoyable experience during your stay in Avignon. Thank you.

### **OIL MILL BRONZINI**

74 Rue de la République - VILLENEUVE les AVIGNON - +33 4 90 25 45 59

Created in 1358, it is one of the oldest oil mills in Provence. The Chartreuse mill, founded by Pope Innocent VI, is located in the heart of the historic center of Villeneuve-lez-Avignon, a stone's throw from the Chartreuse du Val de Bénédiction.

The Maison BRONZINI articulates its activities and its know-how around the Olive Oil, but also its derived products to be found in its store of decoration: delicatessen, natural and organic soaps, cosmetic products, pastries.

You will discover the secrets of the cold pressing of the different varieties of olives during the visit of the mill and, during the tasting, you will appreciate the delicate and varied flavors of the different families of olive oils.

Lunch will be taken on site at the Bistrot du Moulin from 36 to 39 € (without drinks) The payment will be done on the spot.

Jungsook KIM

Jungsook Kim graduated from Korea University for her B.A. in education. She also received her M.A. at Ewha Women's University, and Ed. D. in higher education at George Washington University in Washington D.C. Prior to being involved in politics; she used to teach at Korea University and Jeonbuk University.

Dr. Kim served as the vice minister of women's affairs in the government of Republic of Korea. She also served as a three-term member of the 14th, 15th & 16th National Assembly of the Republic of Korea, Dr. Kim founded and has been running the Korean Institute for Women and Politics (KIWP) since 1989, which is the first national research and training institute focusing on women's participation in politics.

For her contributions to the advancement of women in Korea, she received the Best Achievement Award from Samsung Foundation in 2015 which is given to the most distinguished women leaders in Korea. She also received the Order of Civil Merit (Mugungwha Hunjang); the most honorable order, from the Korean government. In addition, she is the recipient of the Distinguished Alumni Achievement Award (2004) from George Washington University.

Since 2015, Dr. Kim has been working so hard as President of the International Council of Women.

She initiated the program «Women serving women» with actions for the fight against violence against women, the empowerment of women and girls through education and leadership, women committed to water and nutrition, women's health. She has participated in international conventions and congresses of the ISW including the one in Florence «Own the Future Education your Passport to a better life». Holder of a master's degree in private law with a notary option, she practiced the profession of notary from 1979 to 2011, was the first woman President of the Chamber of Notaries of Charente and the first woman President of the Regional Council of Notaries of the Court of Appeal of Bordeaux.

Committed to equal rights for women and men. she is President of University Women of Europe. Until April 2021, she is Vice-President in charge of Equality of the Conference of INGOs of the Council of Europe, one of its 4 pillars.



Madga DE MEYER

Magda De Meyer has been a member of the Belgian parliament for more than 13 years specialised in Social Affairs, Women, Consumers, Children and Poverty. She was head of staff of different Ministers in the field of poverty. as well on the national level as on the regional level. As she was in the Cabinet of the Belgian Minister during the year 2010, the European Year against poverty and the year of the Belgian Presidency of Europe, she was closely involved in the preparation of the Recommendation on childpoverty. She worked as an expert on a report in the Belgian Senate regarding the Belgian policy on childpoverty. Since 2017 she is an independent expert and consultant (social affairs, gender, poverty). Magda De Meyer is Member of the Board of the Fund against childpoverty (King Baudouin Foundation) and former president of the Women's Council in Belgium (Dutchspeaking part). She was also member of the board of the European Women's Lobby and currently General Secretary of the European Centre of the International Women's Council (ECICW).



Marie-Claire KAKPOTIA MORALDO

A Franco-Ivorian feminist humanist activist, social entrepreneur and speaker, she has been campaigning since 2017 for the eradication of female genital mutilation and all gender-based and sexual violence.

Founder and director of the Institut Les Orchidées Rouges in Bordeaux, which is the first care unit in France specialized in the holistic accompaniment of women and girls who are victims of sexual mutilation and forced or early marriage.

Founder since September 01, 2021, of the first medico-psychosocial institute in Côte d'Ivoire dedicated to the global accompaniment of survivors of sexist and sexual violence.

Her NGO has special consultative status with the Economic and Social Council of the UN.

For Marie-Claire Kakpotia Moraldo, freedom is the key for each human being to unfold their potential.

Trained as a lawyer (Master's degree in private law), she began working at AMAV in 1997, creating the first victim assistance service in Vaucluse.

She holds a DEA in geography «Geographers in the city: 1870-1944» (with honors) and a Diploma from the Ecole du Louvre (contemporary art) -1977.

Michèle Vianès, president of Regards de femmes, an association under the law of 1901, created in 1998, NGO with consultative status at the UN ECOSOC and INGO at the International Organization of the Francophonie. She is the coordinator for Western Europe of the Francophone Network for Gender Equality (RF-EFH) and a member of the CNFF executive committee.

From 2001 to 2014, Michèle Vianès was elected municipal councillor in Caluire (69) in charge of gender equality and city policy and vice-president in charge of training for elected officials of the Rhône Association.

A universal feminist and essayist, she is a specialist in gender equality issues and the fight for legal identity.

Her areas of expertise include universal human rights for women, secularism, political parity (encouraging women to run for office and training elected officials), non-sexist education, the fight against all forms of economic, psychological, physical, traditional (excision, early marriages and pregnancies) and sexual violence (prostitution and GPA).

Alyssa Ahrabare, 27 years old, is a lawyer specializing in the rights of fundamental freedoms. A feminist activist for 6 years, she is the project manager of the European Network of Migrant Women and the national spokesperson of Osez le féminisme!

She also works with the Arab Women Solidarity Association Belgium which campaigns for the rights of women from the Arab world. Alyssa has created a theater company that campaigns for gender equality through artistic expression.

Corinne Hirsch, professional equality expert, director of the consulting firm Aeguiso, co-founder and Vice President of the Equality Laboratory. Corinne Hirsch has been an expert in professional equality between women and men for 20 years.

She capitalizes on two dimensions: a career as a Senior Executive in a company (she was the first woman Director at the international level for Yoplait) and a commitment to professional equality.

She has been a co-founder of the Laboratoire de l'égalité for 10 years, and has been Vice President of PWN-Paris (Professional Women's Network) in charge of Think Tanks, notably «Women and Money» and «Women and Ambition». She is the co-author of the film «Women and Money, Let's Talk, Cards on the Table!

She has produced numerous tools to develop a culture of equality.

To make her dual expertise available, she created the consulting firm Aeguiso, which works in all areas of gender equality, with companies, public organizations, associations and women's networks.





Pierre-Yves GINET

In 1996, Pierre-Yves Ginet gave up a career as a financial analyst to become a photojournalist. A great reporter, he discovered women's resistance through an in-depth work on the fight of the struggle of Tibetan nuns, then widenedhis field of action to the whole to the whole world. Since 1998, he has produced about thirty reports on this theme, in very diverse countries, most of them in the book «Women in resistance», published in 2009. 2009. Testifying to these struggles, his work has been exhibited many times, in France and abroad, attracting hundreds of thousands hundreds of thousands of people. In this context, he has accompanied more than six hundred groups to present these forgotten. groups to present these forgotten women, always with the aim of encouraging reflection on gender stereotypes and gender equality.

Pierre-Yves Ginet, one of the founders of the association Femmes ici et ailleurs, is today co-editor of the magazine Femmes ici et ailleurs and director of Les Éditions du 8 mars.

Pierre-Yves Ginet was appointed to the High Council for Equality between Women and Men by the Prime Minister in 2016, a position he held until 2019. A 2014 laureate of the Léopold Sédar Senghor European Cenacle of Arts and Letters (Charles Ciccione Photography Award), he is also a member of the board of directors of the Laboratoire de l'Égalité.

Manon BARBIN For the presentation, it can be said that I created the Manoléta association in March 2018. After 16 years of pain and medical wandering, I thought I was not the only one to experience so many difficulties, violence and humiliations. The goal is to accompany women with endometriosis, to inform their loved ones and to raise awareness among health professionals about what this disease really is. I was lucky enough to have a family that was very present, loving and concerned about my ordeal. But this is not the case for the majority of women who are ill. So I decided to put my heart and my time into this cause to support all these women and hopefully make their lives easier.



### **CAPITAL FILLES**

Created in 2012 in partnership with the French Ministries of Education and Higher Education. the Capital Filles association is chaired by Élizabeth Tchoungui, Executive Director of Jam 50 years old and the mother of a 16 year old CSR, Diversity and Solidarity at Orange. The association is managed by Dominique Goutard, General Delegate.

Capital Filles supports young girls in working-class neighborhoods and rural areas. Its action is based on the joint commitment of «Godmothers», voluntary employees of partner companies and institutions, and teachers who, together, encourage young girls to make career choices and meet the business world.

In 2021-2022, Capital Filles brings together 13 partner companies, founding members, each representing a sector of activity, 14 active member companies and 78 associated companies & institutions

# ICW-CIF HISTORICAL INFORMATION

**The International Council of Women (ICW-CIF)** was founded in 1888 in Washington D.C. The founding members included Susan B. Anthony, May Wright Sewall, and Frances Willard. Fifty-three women's organizations from nine countries were represented at the first gathering in Seneca Falls, New York.

ICW-CIF is a federation or an umbrella organization of National Councils. Only one national council is admitted per country. ICW-CIF is managed by 3 distinct bodies: General Assembly, Executive Committee and Board.

**ICW-CIF** was present and alert when the United Nations was formed, making certain that the United Nations Charter included women's equal rights and that the Commission on the Status of Women could be established. It was at the UN, with ICW-CIF prodding, that the International Women's Year was proclaimed in 1975.

Through the United Nations Decade for Women and four world conferences, including the Beijing Conference of 1995, ICW-CIF was always at the center of the global women's movement, improving the lives of women ail over the world. Over the past 132 years, ICW-CIF succeeded in building its reputation of professionalism while consistently maintaining strong ties with the United Nations.

Working together with women worldwide, ICW-CIF has represented women's views at national, regional, and international levels, mobilized world public opinion, and implemented UN Millennium Development Goals and Sustainable Development Goals in its programs.

One of the first NGOs to obtain general consultative status with UN Economie and Social Council (UN ECOSOC) in 1947, ICW-CIF currently has 40 permanent representatives to UN agencies such as ILO, FAO, ESCAP, UNESCO, UNIDO, UNICEF, and UN HABITAT. In addition to annual participation at UN Conference of the Commission on the Status of Women (UN CSW), ICW-CIF organizes various international seminars related to women's equal rights and empowerment.

Today, ICW-CIF has 25 standing committee coordinators and advisors to form policies by developing the plans of action and to disseminate important information to ICW members on elimination of discrimination and violence against women, equal rights and opportunity for ail, equal access to health care and social protections, child and family, education, environment, and other issues of concern.

**For over 132 years,** ICW-CIF has remained an active pioneer and a leader in representing women's voice and promoting international women's rights.

We, ICW-CIF, will continue to build onto our tradition and redouble our efforts to spur the achievement of gender equality and women's empowerment, which in turn leads to economic growth, sustainable development for the world and a better life for all.

### **PRESENTATION OF CNFF**

The CNFF was created on April 18, 1901, «one of the most important dates in the history of feminism, since it consecrates the alliance of reformist feminism and women's philanthropy, by federating forces that had been scattered until then» (Christine Bard, feminist historian).

A non-political and non-denominational organization, federating women's and feminist associations representing more than 30,000 women, the CNFF has been campaigning for more than a century to affirm the place of women in society and to defend women's rights and equal opportunities between women and men.

### Network

The CNFF is the head of a national network of associations spread throughout France and regional delegations, which gives it an effective representativeness.

The CNFF is a founding member of the National Collective for the Fight against Violence against Women, which carried the Great National Cause 2010 and which led to the law of July 9, 2010 on violence against women and the impact of such violence on children, as well as the Collective Abolition 2012, which inspired the law of April 13, 2016 and the texts of the fight against the prostitutional system and human trafficking.

He is a member of the International Coalition for the Abolition of Surrogacy CIAMS He is also an active member of the collective Ensemble Contre le Sexisme and was a member of the collective G7-W7

He is a member of the Women and Sport Collective

He participated in the working groups of the Grenelle against conjugal violence: Prevention-Education; reception of victims in police stations - health - Overseas

He was a member of the Collectif féministe 2021 of the French women's associations movement for the Generation Equality Forum.

In addition to its importance in France, the CNFF is active at the European and international levels; it is affiliated with the International Council of Women - ICW-CIF - NGO (founded in 1888) with headquarters in France and consultative status with ECOSOC, as well as with the ECICW, European Center of the ICW, member of the EWL, with participatory status with the Council of Europe and consultative status with the European institutions. Three members of the CNFF represent the ICW-CIF at UNESCO in PARIS, and two others represent the ECICW at the Council of Europe. Two of its members represent the ICW-CIF at the United Nations in GENEVA. The ECICW is currently chaired by Brigitte POLONOVSKI, Vice-President of the CNFF.

Every year in March, the CNFF participates in the Session of the Commission on the Status of Women (CSW) as part of the French delegation. At the CSW65, it co-organized with the French section of the EUROPEAN UNION OF WOMEN, UN Women France, the side event «Women's Leadership, an opportunity to transform society (example of legal careers) and at the CSW66, the side event «Air and blue gold, two treasures to be protected to share them».

### Its Purpose

### Its missions

The CNFF is legitimately involved in all national and local debates to affirm the role of women in society, their place and their image.

- in the life of the city (Prostitution-Fight against violence and discrimination against women
- Fight against sexism-Ageing of women-Sport and physical activities -Integration and protection of migrant women - Secularism, an essential element of the women's fight -Europe, the Constitutional Treaty and women -Universal rights of the child - PMA-GPA- cyber-violence)
- ▶ To strengthen its action and increase its impact, the CNFF is forming partnerships with bodies or organizations that work concretely in the field:
- fostering women's entrepreneurship with the Entreprendre au féminin CPME Clubs,
- helping women to empower themselves through sport Rallye Aïcha des Gazelles in Morocco, the collective More women for more sport.
- fight against violence and sexual mutilation with the House of Women of Saint Denis Les orchidées Rouges in Bordeaux

From these themes thus approached by the CNFF, ideas and proposals emerge which are the subject of publications and are transmitted to the actors of the political, professional and social life concerned.


